- **QUINCY MEMORIAL PARK IS OPEN TO THE PUBLIC FROM DAYLIGHT TO DUSK**
- **NO UPRIGHT MARKERS OR SHEPHERD'S HOOKS ARE PERMITTED**
- **NEITHER GLASS CONTAINERS NOR WIRES TO HOLD FLOWER CONTAINERS IN PLACE ARE ALLOWED. THEY PRESENT A HAZARD TO WORKMEN**
- **AS A GENERAL RULE OF THUMB, IF IT DOES NOT FIT IN THE VASE AND IS NOT IN GOOD TASTE – IT IS NOT ALLOWED AND WILL BE REMOVED**
- **NO PARKING ON THE GRASS AS WELL AS NO FISHING WILL BE ALLOWED**
- **NO TREES, SHRUBS, OR LIVE PLANTS ARE ALLOWED TO BE PLANTED ON CEMETERY GROUNDS. POTTED PLANTS ARE ALLOWED ONLY ONE WEEK BEFORE TO ONE WEEK AFTER EASTER AND MEMORIAL DAY**
- **NO FENCE OR ENCLOSURE OF ANY KIND WILL BE PERMITTED ON BURIAL LOTS/SPACES**
- **NO FIREARMS, ALCOHOL, OR DRUGS ARE PERMITTED ON CEMETERY GROUNDS**
- **A PERMANENT GRAVE LINER IS REQUIRED AT THE TIME OF INTERMENT**
- **VASES NEED TO BE RECESSED BEFORE INCLEMENT WEATHER**
- **WREATHS ARE ALLOWED DECEMBER 1ST THROUGH MARCH 1ST**
- **ANY HOLIDAY DECORATION NOT REMOVED BY MARCH 1ST WILL BE REMOVED AT THE DISCRETION OF THE CEMETERY MANAGER**
- **ONLY TWO CREMATIONS PER GRAVE SPACE – SEPARATE OPENING/CLOSING COSTS – AND ONLY WITH THE CONSENT OF THE OWNER OF THE SPACE**

- **NO SPACE IS TO BE USED FOR ANY PURPOSE OTHER THAN AS A PLACE OF HUMAN INTERMENT**
- **A BURIAL PERMIT IS REQUIRED BEFORE INTERNMENT**
- **A THREE DAY NOTICE IS REQUIRED FOR ALL INTERMENTS**
- **WRITTEN PERMISSION FROM THE OWNER OR OWNER'S REPRESENTATIVE MUST BE SUBMITTED FOR THE INTERMENT OF OTHERS THAN MEMBERS OF THE IMMEDIATE FAMILY OR OWNER**
- **THE SAME RULES AND REGULATIONS APPLY FOR A REINTERMENT FROM ANOTHER BURIAL GROUND/LOCATION**
- **PRIOR TO ANY MARKER REMOVAL FOR REFINISHING PERMISSION MUST BE OBTAINED FROM THE CEMETERY MANAGER. ONLY THE OWNER OF THE BURIAL RIGHT OR HIS/HER REPRESENTATIVE(S) CAN MAKE SUCH REQUEST**
- **TEMPORARY METAL MARKERS ARE PERMITTED FOR A PERIOD OF SIX MONTHS AND WILL BE REMOVED AT THE DISCRETION OF QUINCY MEMORIAL PARK**
- **NO SLABS OF ANY DESCRIPTION WILL BE ALLOWED**
- **SALES OF BURIAL RIGHTS AND/OR SPACE ARE NOT VALID UNTIL ENTERED IN THE CEMETERY RECORDS**
- **IT IS THE RESPONSIBILITY OF THE OWNER TO MAINTAIN AN UP TO DATE RECORD OF THEIR ADDRESS AND PHONE NUMBER AT THE QUINCY MEMORIAL PARK OFFICE**
- **QUINCY MEMORIAL PARK SHALL NOT BE LIABLE FOR LOSS OR DAMAGE TO MARKERS, CRYPT/NICHE PLATES CAUSED BY FIRE, LIGHTNING, WINDSTORM, CYCLONE, TORNADO, HAIL, OR ANY LOSS OR DAMAGE CAUSED BY "ACTS OF GOD"**
- **QUINCY MEMORIAL PARK SHALL NOT BE LIABLE FOR ANY DAMAGE TO MARKERS CAUSED BY ACTS OF VANDALISM OR THEFT**
- **QUINCY MEMORIAL PARK RETAINS THE RIGHT TO CORRECT ANY AND ALL ERRORS IN THE PLACEMENT OF A MEMORIAL MARKER AND THE INTERMENT, ENTOMBMENT, OR INURNMENT OF HUMAN REMAINS**
- **QUINCY MEMORIAL PARK RESERVES THE RIGHT TO MAKE SHORT TERM EXCEPTIONS TO THE RULES AND REGULATIONS. THIS WILL BE DONE AT THE DISCRETION OF THE QUINCY MEMORIAL PARK MANAGER**
